Pay Institute website which has been working for two years is part of a project for monitoring and evaluation of the work Kurdistan parliament. This website publicized reports about the four terms of the parliament like that of the CV of MPs, parliament presidency, laws, decisions, temporary and permanent committees.

Regarding the forth term of the parliament from 2013-2018, it has publicized information about temporary and permanent committees, MP CVs, presidency, parliamentary blocs, program works, parliament by-law, tapes of all sessions, the absence of MPs in the sessions, and the list of ties of MPs apart from other reports of parliament in the eyes of the media, infographic of parliament, the brochures of parliament works, parliament publications, views on parliament, daily news on parliament, at the same time paying attention to the news of parliamentary committees and blocs related to legislation and monitoring parliament on public institutions.

Pay Institute publicized all the reports concerning the monitoring of parliament and all the other projects the institute works on them. After working on the Arabic part of the website, in the future English part of the website will be added.



## Introduction

After closing down the parliament of Kurdistan for two years, it opened its doors due to the widespread demand of the people on 15/9/2017 and resumed its sessions. Though, the term of this round should have ended on 6/1/2017 and fifth term of the parliament should have been elected, but the wish of the dominant political parties and the silence of other parties led to the extension of the period of this term to another year without even letting the speaker to come back exercise his power and supervise the sessions, apart from this the speaker submitted his resignation up until now they have neither approved it nor put it in the parliamentary program works.

This report sheds light on the first phase of the extension period of this term from 6th of November 2017 to 6th March 2018 through which it has conducted 13 sessions and ratified 6 bills but for managing the sessions it violated the by-laws many times.

In order to analyze the current situation and to monitor the Parliament as a legal and national institution, Pay Institute published its eleventh report as part of its activities in the exercise of oversight role in cooperation with the National Fund for Democracy Support (NED), an American organization. Our aim is to make voters be aware of their elected representatives and whether the political parties have fulfilled their promises and remind the promises made to citizens during the period of election propaganda and inform the public opinion how the Parliament should exercise its main activities of legislation and oversight.

At Pay Institute, we provide support to parliamentarians by means of clear and accurate information about the parliament. The voters know the level of performance of this institution in order to distinguish active members from others and exert civil pressure on non-active members who do not perform their duties as required. Parliament is the elected institution and the relationship between parliament and public opinion is strengthened. The aim of this project is to bind the voter to the MP and strengthen their relationship.

Despite of creating many hurdles and obstructions in front of our activities as it has been done before by the parliament presidency and other official institutions by refusing to give us information despite that we have notified the parliament presidency via official letters to do our duties lawfully but they continue on obstructing our activities and continued on this non-transparent stances and they violated the very laws they have ratified.

At Pay Institute, we have not ceased to exercise our activities and projects and will not cease as a result of the support by friends and supporters of democracy in and outside the region and active members of Parliament and we continue in our activities in the exercise of the oversight session on the Parliament and to detect the points of imbalance and pressure on the forces and parties that do not seek to activate the parliament in a real way and to do its work as required

## Notes on Parliamentary Sessions

1-No one knows what happen in the first session! Whereas this round resumed its sessions from the second session! This shows the lack of expertise of presidency, for this reason the session of 15/11/2017 in the previous round came as number (5) while in this round the same session came as session number (1). The parliament presidency should have announced the end of this term on 6/11/2017 and should have announced the beginning of another round but they didn't, this shows the lack of awareness of the parliament presidency of the rules and regulations.

2-The session of number(11) is the extension of session number (10), thus, both sessions on 21/2/2018 and 22/2/2018 belong to the same one as mentioned but they branded the second one as number (11). This also indicates the lack of awareness of parliament presidency of the rules and regulations.

3-In most sessions, the program work has been exchanged for example in the sessions number (2) on 6/12/2017, number (3) on 17/12/2017, number (4) on 10/1/2018, number (5) on 30/1/2018, number (6) on 31/1/2018, number (7) on 6/2/2018, number (8) on 12/2/2018, number (9) on 13/2/2018 and number (10) on 21/2/2018. This shows lack of knowledge of parliament presidency in putting a regular program work and lack of parliamentary knowledge.

4-They wasted time in most sessions on the point of order which was utterly unnecessary, this also shows lack of knowledge and awareness of parliamentary rules and regulation by the parliament presidency.

5-In the fourth session, a new paragraph has been added inside the hall of parliament which was reading the report of MP delegation to western Kurdistan (Rojava) whom they have visited Rojava. In accordance with the parliament by-law no subject should be discussed if it has not been put to the program of work. <sup>(1)</sup> This shows disorganization on part of parliament presidency in putting program of work.

6-According to paragraph (3) of the first article of Law No. (2) of 2017 on the law of the distribution of powers of the presidency of the region to the constitutional institutions in the region, the power to ratify the laws were granted to the presidency of the parliament, namely the three members (the president and his deputy and the secretary of parliament). The law passed did not bear the signature of the Speaker of Parliament.

7-One of the problems that the Presidency of the Parliament invented for itself and the Parliament that it raised the doubts of citizens about its work by holding meetings closed without any excuse.

8- In most of the meetings, the program of work was not announced on time or was notified to members of parliament at a later date.

9-That a number of draft laws were not sent to the concerned committees as required when the first reading of them, where the draft laws were sent to the committees of the competent and concerned.

## **Second: The process of legislation:**

### **Issuing laws:**

At this session they have ratified the following laws:

1-Law No. (3) for the year 2017 regarding the second amendment to the application of the law of rents in real estate No. (87) for the year 1979, amended in the Kurdistan region of Iraq.<sup>(1)</sup>

2. Law No. (4) for the year 2017 on granting a general amnesty in Kurdistan region of Iraq.<sup>(2)</sup>

3. Law No. (1) of 2018 on organizing the transplantation and transport of human organs.<sup>(3)</sup>

4- Law No. (2) for the year 2018 concerning the first amendment to the Traffic Law No. (86) for the year 2004 in the Kurdistan Region.<sup>(4)</sup>

5- Law No. (3) for the year 2018 on the excesses on state property.<sup>(5)</sup>

6- Law No. (4) for the year 2018 on retirement, salaries, privileges, grants and allowances in Kurdistan Region.<sup>(6)</sup>

## **Open Discussions:**

The open debates are a kind of discussions that are neither laws nor resolutions and recommendations, which are discussions between the parliamentary blocs and their members in the parliament room, which was during the following period in open discussions:

1. On 6/12/2017, an open discussion was held on the situation in the city of Tuzkurmatu and the situation of the Kurdish citizens in this city who have become displaced in the areas outside Kurdistan region.<sup>(1)</sup>

2 - On 30/1/2018 the parliamentary blocs read their statements on the situation in Afrin and then the Parliament of Kurdistan region issued a statement on it.<sup>(2)</sup>

3. On 21/2/2018 the delegation of the Parliament, who visited the city of Afrin, read their special report.

## **Third: Oversight of the Government:**

Although the Parliament resumed its sessions, but regarding the subject of supervision of the government, it did not exercise any activity and was unable to carry out his duties, except for a number of meetings that convened both the government and parliament. The meetings were part of the government's efforts to implement its agendas through parliament, not to exercise the oversight role of the parliament and to hold it accountable for the legal violations committed by the government, such as compulsory savings on salaries of employees and reduction of salaries to a quarter.

The sale of oil and the lack of clarity of revenues, manipulation of the timing of elections, the emergence of corruption in most sectors, poor health services, education, higher education, roads, lack of fuel, electricity and water, illegal tax increases and dozens of other topics, although a number of members of Parliament raised the memoranda for questioning the Presidency of the Council of Ministers and Ministers, but the Parliament did not listen to them and was unable to hold any government official.

---

(1)–At the request of members of the Parliament of Kurdistan, an open discussion was held on the situation in Tuzkhurmatu and the situation of the Kurdish citizens who were displaced to the other areas of Kurdistan. In the beginning, the administration of the district of Tuzkhurmatu was read to the members of Parliament that was committed against the citizens with the proposal to provide assistance to citizens to return to their areas, and then submitted both the Kurdistan Region Committee outside the region and human rights report by presenting the special facts and the presentation of evidence, documents and victims of parliamentarians, and a number of representatives of the parliamentary blocs present their suggestions and positions on the events that took place in Tuzkhurmatu.

The committees of the Kurdish regions outside the region proper and human rights summarized the demands of the administration of Tuzhurmato and the residents of the region and discussed the members of Parliament in the framework of a number of resolutions and recommendations, which included eight points and pointed to: - An investigation must be set up on the events of 16 October and the days that followed in Tuzhurmato, The allocation of budget to ensure the needs of the displaced people in Tuzhurmato that the victims are considered martyrs and the task of the Kurdistan Regional Government to collect information and evidence as well as document all crimes then send them to the international community and the United Nations. The other point is to ask Kurdistan Regional Government to initial a lawsuit against those who committed crime in accordance with constitutional articles in the Federal Court.

The Kurdistan Regional Parliament called on the Iraqi government to stop and end the violations and crimes committed and resolve all administrative decisions taken after these events. They were voted separately and ratified.

### **Adoption of the budget:**

On the issue of ratification of the parliament, the parliament did not have any role:

1- Over the past five years, he has not approved any of the budgets of the years (2014, 2015, 2016, 2017, 2018).<sup>(1)</sup>

2 - In addition to the failure of the Parliament to ratify the budgets, the government has acted in the budget in accordance with its wishes without the existence of any control monitors its work, so the final accounts for any of the years (2012, 2013, 2014, 2015, 2016, 2017). No one knows how the government acted in this budget and the parliament did not play any role in that.

### **Fifth: The resignation of the members**

1. On 17/12/2017, the resignation of the member (Papir Kamla) was placed on Third Way List bloc in a work program, but when the vote was cast, the request was rejected and did not receive enough votes.<sup>(2)</sup>

1- On 26/12/2017, the Speaker of Parliament (Dr. Yousef Mohammad Sadiq) submitted his resignation.<sup>(3)</sup>

### **Sixth: Committees of Parliament of Kurdistan Region**

The Parliament of the Kurdistan Region includes (22) committees, and that according to the by-law of Parliament, Article (37) thereof referred to the formation of committees and that members of parliament are entitled to membership in these committees in accordance with their wishes and specialties. Any of these committees must not be less than five members and not more than 11 members, and the work of these committees is to follow up the projects and activities of the government and contact with citizens in order to see the problems.

#### **1. Replacement of committee members**

During this period, the following changes were made to the committees:

2 - During the session on (6/12/2017) add the member (Ayoub Abdullah Rasool) to the committee of Agriculture, Livestock, Irrigation and Dams.

3 - During the session on (6/12/2017) accept the resignation of the member (Behzad Darwish Darwish) of the Committee of Construction and Housing and Rural Development and added to the Committee of civil society.

4 - During the session on (6/12/2017) accept the resignation of the member (Bahar Abdul Rahman Mohammed) of the committee of Civil Society Affairs and added to the Committee of Human Rights.

5 - During the session on (6/12/2017) the resignation of the member (Shilan Jafar Ali) was accepted from the Committee of Social Affairs, Children and Family and added to the Committee of Peshmerga and the affairs of martyrs and victims of genocide and political detainees who resigned from this committee.

---

(1)–The Kurdistan Regional Parliament has not ratified the budgets of the Kurdistan region for five years and do not know how to be disposed of.

(2)–Due of an agreement between the components of this bloc, which got one seat in parliament that the representative of this list occupies the membership of parliament for two years, half a period to Bapir completely and the second period granted to Haidua Sayed Salim, which represents the party of hard workers, but by majority vote was rejected the request to resign.

(3)–So far, the request for the resignation of the speaker has not been put on the agenda of parliament.

6 - During the session on (6/12/2017) add member (Mustafa Ahmed Hamad) to the Committee of Endowments and Religious Affairs.

7 - During the session on (6/12/2017) was added member (Koran Mahmoud Ismail) to the Committee of Sports and Youth and the Committee of Industry, Energy and Natural Resources.

8 - During the session on 17/12/2017 the member (Mustafa Ahmad Hamad) was added to the Committee of Antiquities, Municipalities, Communications, Transport and Tourism.

9. On 10/1/2018 the resignation of the member (Saleh Bashar Saleh) was accepted by the Committee of Industry, Energy and Natural Resources.

10. On 10/1/2018 the resignation of the member (Haifa Haji Mirkhan) was accepted by the Committee of Trade and Consumer Protection

11- On January 10, 2018 the member (Ali Osman Ali) was added to the Committee of Industry, Energy and Natural Resources.

12. At the session on 10/1/2018 the member (Saleh Bashar Saleh) was added to the Committee of Trade and Consumer Protection

13. In the session on 10/1/2018 the member (Haifa Haji Mirkhan) was added to the committee of Industry, Energy and Natural Resources.

14. At the session on 30/1/2018 the member (Ayoub Abdullah Rasool) was added to the Parliamentary Affairs Committee

15- On January 30, 2018, member Abdul Rahman Faris Abdulrahman (Abu Karwan) was added to the Civil Society Affairs Committee

16. At the session of 6/2/2018 the member (Berri Saleh Hamid) was added to the Committee of Education and Higher Education and Scientific Research

17. At the session of 13 February 1986, the member (Delir Mawati) resigned from the Committee on Peshmerga Affairs, Martyrs, Victims of Genocide and Political Prisoners.

18- At the session on 13/2/2017 the member (Ari Abdullatif Mouloud) was added to the Committee of Culture, Information and Arts.



## 2 - Meeting of committees of parliament:

Pay Institute relies on its information on the website of the Parliament on the meetings of the committees of Parliament because of the Presidency of the Parliament under the letter No. (4/4/452) issued by the Directorate General of the House of Parliament and at the request of the Deputy Speaker of the Parliament on (27/2/2017) the Pay Institute and all members of Parliament, which indicated that all information on this organization should be withheld by parliament. It was as follows:

### **Observations on Committees Meeting:**

1 - During the last session, which lasted for six months, all committees held (13) meetings either during the current session or continued four months ago, these committees held 110 meetings.

2 - The reason for the large number of meetings of the committees that the presidency of the parliament allocated financial allowances to members in addition to their salaries provided that participation in meetings and write minutes of meetings.

3- According to the follow-up conducted by me, most of the meetings were superficial in order not to accuse these committees of not holding meetings, and part of these meetings were limited to visits or reception of guests, or were mentioned as a regular meeting of the Committee, without having any result.

4- Although a large number of committees have been held, they have resulted in a few reports on draft laws and a small number of controls have been exercised on government activity.

### **3. Writing reports on bills:**

So far, there have been (190) first reading of the bills in the parliament and was sent to members of parliament and the committees concerned, and a number of projects were submitted by members of parliament, but so far has not been read, and the total projects laws and resolutions ratified during the last session and continuing four and a half years ago, (30) laws were passed (7) resolutions, while the rest remained the same.

And according to the website of the parliament, no committee has written any report on the draft laws transferred to it, except for the six laws and ratified and the committees wrote their reports.

Of the total reports that the committees had to write which should have been (445) reports, the committees over the past four and a half have written (137) reports, and so far (308) have not been written which were supposed to be written.

### **The resignation of the Speaker of Parliament**

After the elections of Kurdistan Regional Parliament in September 2013, and according to the agreement of the political parties, during the parliamentary session on 29/4/2014 was elected the president of Parliament and the selection of (Yusuf Mohammad Sadiq) Chairman of the Parliament of Kurdistan region of the mass movement of change, and continued in his duties until launching the draft law amending the presidency of Kurdistan region in August 2015 in the work program of parliament by Change Movement and the Islamic Union and the Patriotic Union of Kurdistan and the group which led to problems between these parties with the Kurdistan Democratic Party, and then under the pretext of supporting the movement of change to the demonstrations, the Speaker of Parliament was prevented from entering the city of Arbil on 12/10/2015 where the Speaker was prevented from crossing the point of control of Prde and his work in Parliament, after that did not hold parliamentary sessions and prevent the entry of the Speaker of Parliament to the parliament, after the resumption of parliamentary sessions. On 15/9/2017 in order to support parliament to the subject of the referendum held the first parliament, but continued to prevent the Speaker of Parliament, 2017 when the speaker of parliament submitted his resignation to parliament.

According to the first paragraph of Article 16 of the rules of procedure, which indicated that "in the case of a member of the Presidency of the Parliament to resign from his post, the acceptance and approval of the resignation after a majority vote of the members of Parliament on that." In the second paragraph of the same article indicated that "<sup>(1)</sup> The absence of the position of the Speaker of Parliament or his deputy or the Secretary of Parliament for any reason, the Parliament in the first session is held after the vacancy of this position, the Parliament select the alternative for them in accordance with the method mentioned in the rules of procedure, "but it is surprising that after his resignation Speaker of parliament held 10 sessions without Place a resignation request The Speaker of Parliament in the Parliament's program of work, and this is a clear violation of the laws and the rules of procedure of Parliament.

The strange thing in the matter is that the influential parties are insulting the laws and public institutions openly. The Speaker of Parliament has been prevented from returning to his work and supervised the meetings two years ago. The Speaker of Parliament has submitted his resignation four months ago and this is considered a blatant legal violations practiced by the Presidency of Parliament at the will of political parties and members of parliament are silent about them.

## **The law of reforming in retirement, salaries, allowances, grants and other privileges in Kurdistan region**

The draft law on reforms in retirement, salaries, allowances, grants and other privileges in the Kurdistan region, which was submitted by the Council of Ministers to the Parliament, and in session No. (4) of 10/1/2018 was the first reading and was referred to six committees to write reports and after the writing of the reports of the committees with the existence of different views around them were placed in the work program of Parliament and discussed in meetings (10, 11, 12, 13) and was approved in a meeting on (27/2/2018).

The ratification of this law has become a talk of the hour by the citizens and the media means of social communication, where the members of parliament have been attacked and insults directed at them.

Here are a few quick notes on this law:

**First:** this project was comprehensive, but the focus was on the retirement of members of Parliament by the media, without any one of them reading the law and not being familiar with the circumstances in which the discussion sessions were conducted and did not see the discussions of members of parliament because the meeting was closed, Defamation, accusation and insulting of others can not be practiced without having any information about it.

**Second:** the law amends many legal violations which the government has implemented, and this did not require a law. However, the government was supposed to correct these violations by decisions and resolve its illegal decisions because all decisions And the granting of salaries to the deceased collaborators with the former regime and other persons who were not part of the Peshmerga forces and their inclusion in the lists of martyrs, and the inclusion of people in lists of political prisoners and the granting of salaries to them unlawfully) in addition to many other subjects, which was practiced illegally by the government and not parliament, and that the solution of these subjects are the authorities of the government and do not need law and parliament.

**Third:**, the only action that the parliament should have was to hold the government accountable for the legal violations it committed, not to issue a law on this subject, in addition to reviewing the large salaries organized under the laws, taking into account social justice in this matter.

**Fourth:** Sending a draft law on this subject at this time by the government is for the practice of political bidding on members of Parliament and among citizens with the aim of insulting the members of Parliament and reducing the status and place of parliament as an institution, so that they can hide the illegal work and mix the papers and increase the number to urge citizens not to participate in the elections, in order to practice fraud during the elections and to continue in power.

**Fifth:** In the past, some political parties made great efforts to undermine the status of this institution, and they were calling the status of adolescents and newcomers to the members of Parliament, and they believed that the law of the presidency of the province is not the functions of Parliament and political parties have agreed on this issue outside parliament and they were waving their fingers at parliamentarians. They state that they will not accept them, and they closed the doors of the parliament for two years, and they prevented the speaker of parliament and they do not approve the request for his resignation.

**Sixth:** If the government is seeking through this law to carry out the reforms increase revenues as claimed and announced, the proceeds are not increased by blocking these small

amounts, but must be revenues of oil and customs and local revenues transparent in order to increase these revenues and concealment, estimated at hundreds Millions of dollars, but they can not give employees a quarter of their salaries.

**Seventh:** Despite the many observations on this law, it was a good step, and it should be viewed on based on the following points:

1- Securing the rights of those who receive salaries in the region from the money that has been withheld from them in the name of compulsory savings and added to their bank account.

2 - The salaries should not be less than 300,000 dinars

3 - Solving the assignment of others eligible for retirement at high salary and who did not occupy these jobs

4 - Correcting or canceling the retirement assignment for those referred to retire illegally or at a higher level than their rank and entitlements.

5- Unifying of all the units of obtaining salaries on pensions in the Directorate of Retirement of the Ministry of Finance.

6- Unifying the accounts of the seventy-eight units within the Ministry of Peshmerga.

7 - Purifying the records of the names of martyrs and political detainees and war invalids of non-eligible persons.

8 – Restricting the number of guards in headquarters and with officials, and eliminate injustice and imaginary personnel so as not to waste money in this area and the unification of guard units within the Ministry of the Interior.

9- Unifying the allowances.

10- Develop a pension fund and prevent the disposal of any amounts from this fund.

These things are for the benefit of citizens in the region, the demands of citizens and civil society organizations.

**Eighth:** The pensions of members of parliament were another point, because the Parliament is an independent authority. It should not have been placed under this law instead it was supposed to issue a law on the salaries and retirement of members of Parliament by amending the by-law of parliament (the parliament is in the process of amending its by-law at the present time) in a way that guarantees the rights of members of parliament and commensurate with the principle of social justice.

In the past, all members of parliament were referred to retire according to the laws and had no way to return to their former jobs, but under a paragraph in this law, the retirement became optional, and any member of parliament refuses to refer to retirement is entitled to return to his former position, and that was a good way out for those who sought to retain the pension and return to the job as well as to run the injustice against members of parliament after being accused of having increased their salaries, this is not true at all, and vice versa, they have reduced their salaries, since the introduction of compulsory saving system and during the period that was the granting of salaries on time were members of Parliament are referred to retire and receive (80%) of their total salaries and allowances, but according to this law has been reduced to 25% (60%), although this does not mean that this amount is low, but the following points should be considered:

1 - Members of Parliament can be classified, as each of them was holding a post and a position before becoming a member of Parliament, and after the end of their task in parliament to look at their future and their lives and justice, so as not to harm them and not granting them many privileges that are incompatible with the principles of justice, where it is unreasonable to deprive parliamentarians who have spent long periods in the public service to

retire and return to their former jobs after their service in parliament as if they were subjected to punishment.

2- Must take into account the age and years of service and scientific certificates in it.

3 - The international standards used to determine the fate of members of parliament after the end of the parliamentary session, whether they are reinstated to the post or anything else, must be relied upon.

**Ninth:** For the information and information that the members of Parliament referred to retirement at the present time (March 2018) receive a salary for the month of March 2017, that they did not receive the salaries of the current year 2018 and that during the past year 2017 received half of the salary for only two months, For one month in one year, and he and other retirees in the Kurdistan region have not received their salaries for three months.

**Tenth:** It was supposed to be the minimum pension 400 thousand dinars instead of 300 thousand dinars as stipulated in the Federal Retirement Law in Iraq No. (9) for the year 2014, and most importantly, they should receive their salaries regularly with the staff (although the salaries of employees Not also distributed regularly).

**Eleventh:** Citizens must be more aware and do not fall under the influence of the plans put in place by the Authority. The government and the influential parties are seeking to undermine the status of the parliament. They are seeking to insult members of parliament, and that the institution of Parliament should be seen as a sacred and high-level institution, lobbying parliamentarians for reforms, and that these parties sought to paralyze parliament's capabilities, and that they carried out many illegal acts and abuses through parliament.

**Twelve:** As a result of the large public pressure, a number of parliamentary blocs expressed their dissatisfaction and claimed that they are not satisfied with that, and on 4/3/2018 decided to head the parliament rejected the law and returned to parliament for discussion.

**Thirteenth:** The Presidency of the Parliament issued two contradictory decisions within one day and both resolutions were issued with a number and date one and both were No. (1), both issued on (4/3/2018) and both decisions were made by the Deputy Speaker of Parliament and the Secretary of Parliament to sign, The two decisions were published on the website of the parliament. In the first decision, the law was rejected. In the second decision, a number of paragraphs of the law were rejected, and here we do not know which is true and whichever is being done, and that indicates the lack of organization and lack of experience of the presidency of the Parliament of the Kurdistan region.<sup>(1)</sup>

**Fourteen:** The objections to this law will not reduce the pensions of members of parliament at the present time, but the old law is applied at the present time, which amounts to more than twice the amount specified in the new law.

**Fifteen:** There is talk that the same mechanism will be followed in the retirement of members of the Iraqi Council of Representatives on the subject of retirement members of the parliament in the region, according to the Federal Retirement Law No. (9) 2014, and that means that the pension will exceed the amount specified in the law that was He refused.

**Sixteenth:** The law that has been returned to parliament must be fair. In the case of the application of the Federal Pension Law (9) for the year 2014 regarding the retirement of members of Parliament, the law should be applied to all retirees in the region and their salaries should be identical with their peers. In the rest of Iraq and increase.

## **Violations of the by-law in holding parliamentary sessions**

- 1- Violations were carried out in most of the sessions of Parliament
- 2 - The Speaker of Parliament submitted his resignation, but so far has not been included in the agenda of the Parliament, and that this is contrary to the by-law of Parliament.
- 3- In most sessions, the agenda has not been announced, or if it has been announced, the members of Parliament are notified about it shortly before the start of the meetings. At the same time, 48 hours from the start of the session.
- 4 - Most of the sessions of the parliament were closed, and were held away from the eyes of the media and citizens, without the introduction of any sensitive topics which require in accordance with the rules of procedure that these meetings are confidential.
- 5 - There are a number of members of the parliament are absent at all times and to participate in the meetings, no action was taken against them.
- 6 - All the courses held should be called a label, such as spring or fall, but the fall session was launched on three consecutive sessions.
- 7 - This session should have been started on 6/11/2017, but the last session of the previous one was the fifth which was held on (15/11/2017) and the first of this session was session No. (2) held on (6/12/2017), meaning that the session (1) is non-existent!
- 8- Of the total (97) items on the agenda of the parliamentary sessions, 34 were implemented and 63 were not implemented.
- 9 - A number of members of parliament resigned from the committees without being replaced by others in these committees.
- 10 - The committees that have undergone changes, has not changed the names of committee members on the website of the Kurdistan Regional Parliament.
- 11 - The names of new members of parliament were not added to the names of the parliamentary blocs on the website of the parliament.

## Results

1- On (15/9/2017), Kurdistan Regional Parliament resumed its meetings, but so far the parliamentary sessions have not been resumed effectively.

2 - The statements of all parties do not conform to their actions

4 - Non-implementation of laws, decisions and recommendations of Parliament by the executive authority

5 - The role of parliament in the political arena is absent and that it has been marginalized in important and fateful events, although under Resolution No. (1) of 2005 obligates the Kurdish political leadership to return to the parliament in the crucial decisions.

6- During the current session, 13 meetings were held, and this is inconsistent with the parliamentary work. The violations have been practiced in most of the parliamentary sessions.

7- In most of the parliamentary sessions, the program of work of the meetings was not announced.

8 - Most of the sessions of the parliament that was held were closed, and was held away from the eyes of the media and citizens, without being raised any sensitive issues where the internal procedure requires that these meetings are confidential, and that led to a break between citizens and members of Parliament and citizens They look suspiciously at the parliament.

9 - During the fourth session of the Kurdistan Regional Parliament until the preparation of this report, which lasted for four and a half years, during which was issued 30 laws and seven resolutions only, although it conducted a first reading of the (190) for a bill.

10 - During the session held the first reading of six federal Iraqi laws to be applied in the region, and that is a double weakness of the Kurdistan Regional Parliament, which must have its own laws and not rely on Iraqi laws.

11 - So far that the parliament was unable to follow up and accounting for the issue of export and revenue of oil has not been the details of oil contracts on them.<sup>(1)</sup> Although the parliament ratified the law of the Fund for oil revenues in the Kurdistan region, but the government without returning to parliament took steps In this direction has not complied with this law.

12 - Although the parliamentary committees held the largest number of meetings, but did not follow any of the activities of the government did not write reports on the draft laws and did not exercise its functions as required.

13- The concerned committees did not exercise their duties in the required manner in the control of the government and did not follow up the projects that were allocated budgets in the past years and are still ongoing, although the Bureau of Supervision must do this task also.

---

(1)-In Article (42) of the by-law of Parliament indicated:

1. The Standing Committees shall, through the Vice-President of the Parliament, urge them to request the official institutions and civil organizations to provide them with the required information on the topics at hand.

2. In the event that the parties mentioned above do not refrain from providing the permanent committees with such information in this case, it is through the Parliament that the head of the provincial government is notified. In case of non-response within 15 days, this matter is referred to parliament for consideration.

14- No minister has been invited to the Parliament for the purpose of questioning him.<sup>(1)</sup>

15- The total number of draft laws referred to the committees amounts to (445) draft laws and the committees should have written reports about them, but was written (137) report by the total committees, that is so far has not been written (308) report so far, and this contradicts the by-law of Parliament.<sup>(2)</sup>

16- The legal period of the Chairman of the Human Rights Commission has ended since 17/1/2017 and the Chairman of the Integrity Commission since 13/5/2017. This was supposed to be resolved in accordance with the laws, but no action was taken. This contradicts with the existing laws.

17 - The Speaker of Parliament has submitted a request to resign from his post, but so far has not been placed on the agenda of the parliament and that this is contrary to the rules of procedure of the parliament.

18 - The committees that have undergone changes, has not changed the names of committee members on the website of the Kurdistan Regional Parliament.

19 - Some members of parliament are constantly absent, and no action was taken against them.

20- On December 19, 2017 Raboun Maruf was arrested by the security forces during his participation in the Sulaymaniyah demonstrations.

21- All the rounds held should have a name, such as spring or autumn, but the fall session was launched on three consecutive sessions.

22-The lack of organization visible on the parliamentary sessions, such as the absence of names for the parliamentary session and the lack of scheduling dates, and that the numbers of meetings overlapping, and that in most sessions of the parliament there was a change in the paragraphs of its agenda, and that during the sessions got added to the paragraphs of the agenda of the meetings, And the lack of experience of the presidency of the Kurdistan Parliament.

23- In accordance with paragraph (3) of Article 1 of the law concerning the distribution of the powers of the presidency of the region to the constitutional institutions in the region No. (2) for the year 2017, that was granted the authority to ratify the laws to the Presidency of Parliament, i.e. the three members of the presidency of the parliament (President and Vice-Secretary) Of these laws have not been signed by the Speaker of Parliament.

24 - One of the problems that the Presidency of the Parliament invented for itself and the Parliament led to the creation of suspicion among citizens is that it held a number of sessions closed without any reason.

---

(1)-In Article 69 of the by-law:

1. In the event that any Member of Parliament asks a member of the Executive, it shall be in written formal letter  
2. The Speaker of Parliament shall deliver the question to the Executive Authority after it has been placed in the program of work of the first session after being notified, and this matter shall be discussed within one week of being notified in the event of the Parliament's delay and the approval of the member of the Executive Committee.

(2)-In Article (71) of paragraph (4) of the by-law of Parliament: - A joint report shall be submitted by the two committees after being drafted by the Legal Committee 10 days after it is referred to the two committees. If they are called upon to rush to consider It is presented within (5) days.

## Recommendations

1- In order to hold free and fair elections, the Parliament must compel the Electoral Commission and the government to prepare a free electoral register.

2- In order to hold elections on time, parliament must compel the prime minister to set a date for holding elections as soon as possible.

3 - Parliament must oblige the government to allocate a budget to the Commission in order to prepare for the elections, so that the Commission can carry out its legal tasks and preparations for the holding of elections on time.

4 - Parliament must include the request for the resignation of the Speaker of the Parliament (Dr. Yousef Mohammed) to the agenda of the Parliament and be voted on.

5- Non-repetition of violations of the by-law, which took place during the holding of meetings, whether the Presidency of the Parliament carried out or is responsible for the occurrence.

6 - The Kurdistan Regional Parliament should have a clear position on the issue of withholding the salaries of the employees of the region and paying a quarter of their salaries regularly, and the government continues on these violations.

7- The Parliament shall compel the government to disclose all the revenues of the region.

8- The Kurdistan Regional Parliament should have a clear position on the violations of the laws committed by the executive branch







## **A Brief About PAY Institute For Education And Development**

PAY Institute has registered by the Non-Governmental Organization Department of the Kurdistan Regional Government in November, 2013. PAY is a Kurdish non-governmental independent, non-seeking profit .

### **A Summary On The Institutes' projects:**

#### **1. A Common Project Among Civil Society Organizations And High Educational Apparatuses In The Kurdistan Regional Government.**

This project which the institute carried out and its fund which was provided by the non-governmental organization department and tried to interpret the 2013 mandate number 5 of the Kurdistan parliament on the common agreement and development among general authorities and non-governmental organizations in the region of Kurdistan. This project included four workshops, gathering with the presidents of all universities in Kurdistan regional government and holding a two day conference. The participants signed a partnership agreement about common work and presented some suggestions to the concerning participants. The project longed for a year.

#### **2. The project Of Monitoring The Kurdistan Parliament**

This project includes the monitoring and evaluation of the work of the Parliament of the Kurdistan Region based on (the principle of the development of laws and oversight of public institutions), and that the project publishes semi-annual reports and so far year published (11) reports and part of the project includes a website called (Observatory) (In Kurdish and Arabic) and disseminates information. This project is implemented in cooperation with the National Fund for Democracy Support (NED).

#### **3. The project Of Monitoring on the work of the Ministry of Education**

This project has published four reports on the work of the Ministry of Education:

##### **The first report:** A Workshop About The Phenomenon Of Studying Abandon In Kurdistan Region

This project included a contribution workshop between both the international cooperation for human value organizations and PAY Institute for Education And Development about lessening and decreasing the range of this phenomenon in the region of Kurdistan which was held on (June 18,19 / 2014) in Erbil province, with a number of 120 attendants including the parliament representatives, ministries, organizations and mass media apparatuses. This project like the previous ones fulfilled in a voluntary way.

##### **Second report:** The project of Monitoring Of Educational Ministry's Works

This project published at (June 25, 2014), it included 101 points report on the problems of education and study in Kurdistan Regional government. With the commencement of the new cabinet of Kurdistan Regional Government, this report was presented to the Minister of education in presence of professors, organization representatives and media apparatuses of the Kurdistan Regional Government.

**Third report:** contributing to further activating vocational education in the provinces of Sulaimani and Halabja The project was a field project aimed at highlighting the problems facing vocational education and suggested solutions conducted by PAY Institute for Education and Development and Halwest Organization in cooperation with Public Aid Organization (PAO) and Norwegian People Aid (NPA). The project consisted in three workshops, brochure distribution and a research. It was carried out between 1/ 5/ 2017 and 1/ 10/ 2017.

**Fourth report:** Private Education between Quality and Business (Problems and solutions) The project consisted in a report prepared on private education in Iraqi Kurdistan and its problems as well as suggested solutions. The study took Sulaimani provincial center as a sample and it was implemented by PAY Institute for Education and Development in cooperation with Norwegian People Aid (NPA) and Reform Institute for Development (RID). The study was completed and carried out between 1/ 7 / 2017 to 1/ 10 / 2017

#### **4. The Project For Monitoring Of Works By Ministry Of High Education And Scientific Research**

This project had published at (July 22, 2014) included a 140 points report on the problems of the high education ministry in the Kurdistan regional government, which delivered to the Minister Of High Education in presence of university professors, organization representatives and media apparatuses of the Kurdistan Regional Government. At the end it was decided that the causes of this phenomenon to be analyzed more, the ultimate resolution and report to be sent as well to all the university authorities of the region. This project was carried out voluntarily too.
