Today the teachers' and employees' strike enter its Fourteenth day. Their demands are summarized in four points attached to our memorandum, which are the basic and legal rights that have been taken away from the people of Kurdistan by the authorities, and they are demanding their restoration. Their demands have been expressed civilly, and in this pursuit, their health condition has deteriorated and is reaching the point of near death. Regrettably, you leaders and officials, who are the cause of these miseries, didn't listen to them and resorted to insults and name-calling.

We, Civil Society Organizations, while considering their demands legitimate and supporting them from the first moment, have always tried to be a bridge between strikers and the authorities to achieve better understanding and prevent tension and unrest. For this purpose, we submitted memorandums and made requests and appeals, but unfortunately, as always, you took no steps and didn't listen. Now, if after Fourteenth days, you remain indifferent to the death of your own citizens and don't consider yourselves responsible for them! However, we, Civil Society Organizations, are not like you – we consider ourselves as the rightful owners of this Kurdistan's land, soil, and stones, and these heroic strikers, who are the living conscience of the Kurdish People, are our brothers, sisters, sons, and daughters. We cannot abandon them and let go because of your indifference. You are indifferent to their death, just as you were indifferent to citizens' death and starvation in the past. We will protect our heroes, these living hearts of Kurdistan's people, and won't allow them to lose their lives before our eyes. We will protect them and prepare ourselves for the next stage of our civil struggle.

The brave strikers have managed to revive the spirit of civil struggle, resurrect the spirit of resistance in hearts of deprived citizens, and better prepare them for the next stage. They have managed, at the expense of their health and burden on their families and relatives' lives, to prove to everyone that this authority does not listen to any civil demands and only cares about plunder and self-imposition. These heroic strikers, by approaching death, have proved the shame of this authority to everyone.

In this regard, we request our heroic striking brothers and sisters, if the authority doesn't respond as soon as possible, to end the strike at the request of us organizations and hundreds of writers and, intellectuals, public figures and thousands of concerned and loyal citizens, and prepare ourselves for the next stage. We also assure the authority that in case of any undesirable consequences, they bear the responsibility.
